- 1.) Types of Season Passes - Two types of Season Passes are available:
- a.) Full – weekdays, weekends and holiday play, with cart. Each household member may be added at the respective full rate. If the first household person chooses a Full Season Pass, each additional household Season Pass Holder is charged at the full rate per the rate schedule.
- OR**
- b.) Weekday – Non-holiday weekdays, with cart. If the first household person chooses a Weekday Season Pass, each additional household Season Pass Holder is charged at the weekday rate per the rate schedule.

2.) Rate Schedule: A household member is a person occupying the same residence not exceeding two adults and either adult’s dependents 22 years of age or younger.

Notes

- 1.) Daily rates for 18 years old and younger are 10% off the rates set above.
- 2.) Nine-hole rates available after 4:00 p.m. are half of the full rates described above.
- 3.) Fees for league play, group outings, and events are negotiated per league, group outing, or event. An event is defined as a reservation for a group of 12 or more golfers prepaying for the necessary block of the times to accommodate the group. Group outing is defined as a group that has signed a Lancaster Golf Club 2022 Group Outing Contract.



## SCHEDULE 2 AND 3

### Cart Rental Agreement

#### Terms of Agreement.

- 1.) Season Pass Holder (“SPH”) acknowledges that each time a cart is used, the SPH will have examined the cart and will, prior to usage, notify Lancaster Golf Club personnel (“LGC”) of any damages or defects of the golf cart.
- 2.) SPH shall return the cart to LGC at its designated cart return area upon completion of the round. The cart shall be returned in the same condition as when received, ordinary wear accepted.
- 3.) SPH shall be responsible for all damages to the cart during its use by SPH and shall reimburse LGC upon demand for the loss of, or any damage to the cart, and/or any of the premises of LGC.
- 4.) SPH shall indemnify and hold LGC harmless from and against any and all liability, including bodily injury and property damaging arising out of the use or operation of the cart by SPH or anyone using or operating same with LGC’s express or implied consent; provided, however, LGC shall be responsible for loss or damage resulting from LGC’s sole negligence.
- 5.) SPH shall obey all rules and regulations of LGC governing the use of the cart and the use of the golf course currently in force or which may be promulgated in the future.

#### Golf Cart Rules

- 1.) Operator of the golf cart must be 18 years of age or older and have a valid driver’s license.
- 2.) Operator shall not be under the influence of any intoxicating substance (i.e. drugs, alcohol, etc). Upon such event, use of the golf course is revoked and shall cease.
- 3.) Horseplay, racing, or other misuse will not be tolerated.
- 4.) Audio speakers, radios, cell phones, and other equipment that amplifies sound shall be kept at volumes that do not project the sound beyond a 5-yard radius of the cart and shall not annoy the comfort of other golfers.
- 5.) LGC may restrict the use of carts to certain areas of the course, or to restrict the use thereof because of weather conditions such as electrical storms and hazardous weather conditions. Upon the sounding of the alarm, all carts must be returned to the cart area or to shelter areas scattered around the course until the all clear is announced.
- 6.) All carts shall be returned to the cart return area on or before course closing time.

#### Acknowledgment of Assumption of Risk and Waiver of Liability

- 1.) SPH understands that driving a golf cart and playing golf involves risks and dangers of serious bodily injury. Said risks and dangers may be caused by my own actions or inactions, the action of others participating in the activity or the conditions in which the activities take place. There may be other risks, social and economic losses, either not known to me or not readily foreseeable at this time. I fully accept and assume all such risks and responsibility for all costs of any injuries or damages incurred as a result of my participation in any activity on the premises of LGC and that of any of my dependents.
- 2.) SPH hereby releases, discharges, indemnifies, and holds LGC harmless from any liability, claims, demands, losses or damages caused by my or my dependent’s actions on the premises of LGC.
- 3.) SPH attests that he/she understands its terms, has agreed to its terms and intends to be a complete and unconditional release of all liability that LGC may have. If any portion of this Agreement is held invalid, the rest of the Agreement shall continue in full force and effect.



## Schedule 4 - Rules of Play, Dress Code & Etiquette

- 1.) USGA rules of golf apply at all times, except as modified by local rules. Local Rules include:
  - a.) Fence lines, road or parking areas are considered out of bounds even though unmarked;
  - b.) All wilderness areas shall be considered hazards;
  - c.) May play out of bounds ball in fairway opposite point of entry and add two (2) strokes;
  - d.) If traps have been washed out by a storm, take relief by raking and placing the ball in the trap;
  - e.) Free drop from all flowers, planted shrubs, cart paths and sprinkler heads.
- 2.) Players shall replace divots on fairways and tees. Repair all ball marks on greens. (Fix two while you are at it).
- 3.) Players are to rake sand in bunkers and leave the rakes in the bunkers.
- 4.) Appropriate golf attire must be worn, as determined by the Director of Golf Operations.
- 5.) Carts are not permitted in the areas between the green and surrounding bunkers, across tee boxes, on greens, or native areas. Mobility flags may be approved by the Director of Golf.
- 6.) No more than two players are allowed per golf cart.
- 7.) Each player must have their own set of clubs; no more than one player may play from one bag.
- 8.) Allow faster groups to play through. Please play "ready golf".
- 9.) Obscene, profane, abusive language shall not be used or tolerated.
- 10.) Throwing clubs or willful damage to the course (i.e. damaging of greens or hitting club into the ground causing damage) will not be tolerated.
- 11.) All players must check in to the pro shop prior to starting their round.
- 12.) All players must start on hole #1 unless approved by staff.
- 13.) Single players and 2-somes will be joined with other players to make a 3-some or 4-some when deemed necessary by the staff.
- 14.) Groups of five or more are not permitted unless there is prior approval by staff.
- 15.) No outside beer, alcoholic beverages, or coolers may be brought onto the course.
- 16.) Sound amplifying devices such as speakers, radios and cell phones shall be kept at sound volumes that do not project the sound beyond a 5-yard radius of the cart and shall not annoy the comfort of other golfers.
- 17.) Course may be reserved for tournaments and events at the discretion of LGC.
- 18.) Animals are prohibited unless service animal accompanying person with disabilities.
- 19.) It is expected that a round of golf should not exceed four hours and 15 minutes. If a hole is open ahead of a group, the staff may order one of the following options:
  - a.) Close the gap and maintain position. Less skilled golfers should still play on-pace golf: pick up after taking 9 strokes unless in tournament;
  - b.) Step aside and allow faster groups play through before resuming play.
  - c.) Skip the next hole to get back in position.
  - d.) If a group is unable to keep up with the normal pace of play, after the second warning, they will be requested to leave the course and a rain check will be given to use at a less busy time.
- 20.) Golfers are responsible for all damage to the course, course equipment, surrounding property and vehicles on the roadway in parking lots.
- 21.) Rain check policy:
  - a.) 5 holes or more constitute 9 holes;
  - b.) 13 holes or more constitutes 18 holes;
  - c.) Prorated credit on future fees for daily play in situations where inclement weather has caused cessation in play without continuation. No cash refunds.
- 22.) Young persons, under 13 years old, are to be accompanied by an adult 18 years old or older who accepts responsibility for their safety and behavior.
- 23.) Persons 13 years through 17 years old may play without an adult before 3:00 p.m. or after 6:00 p.m., unless in organized group activity.
- 24.) Policies for junior play 17 years old and younger may be relaxed during periods of light play at the discretion of the Director of Golf Operations.
